





BRUSH COLLECTION SCHEDULE

Township officials announced in June that Brush will be collected on a monthly basis. This trial program will run through December, 2023.

The collection program will follow the monthly schedule below for the remainder of the year:

October, 2023:

Week of 10/2- Zones 1 and 2 will be collected

Week of 10/9 – Zone 3 will be collected

Week of 10/16 - Zone 4 will be collected

Week of 10/23 - Zone 5 will be collected

Week of 10/30 – crews will complete any areas that may have been

delayed

November, 2023:

Week of 11/6 – Zones 1 and 2 will be collected

Week of 11/13 – Zone 3 will be collected

Week of 11/20 - Zone 4 will be collected

Week of 11/27 - Zone 5 will be collected

December, 2023:

Week of 12/4 - Zones 1 and 2 will be collected

Week of 12/11 - Zone 3 will be collected

Week of 12/18 - Zone 4 will be collected

Week of 12/25 - Zone 5 will be collected

Requirements for brush collection will remain the same. All brush must be placed at the street no earlier than ten (10) days before a scheduled collection. In the fall months, brush and leaves must be separated. Brush must be at the street by 6 am on the Monday of the scheduled collection week. Each street will be collected once.

The Department of Public Works is pleased at announce its last scheduled free residential shredding event for 2023 will be on Saturday, October 7th, 2023 from 8:00 am to 12:00 noon at the DPW Yard, located at 2 Commonwealth Drive (behind Bob Meyer Park)

FOR MEDFORD TOWNSHIP RESIDENTS ONLY -- ABSOLUTELY NO BUSINESSES WILL BE PERMITTED Protect yourself and your family from identity theft and financial fraud while taking steps to help the Township's Recycling Program.

Residents may bring up to 5 boxes or bags of files (no exceptions) to be shredded on site. An experienced operator will be present in a highly secure, mobile shredding unit where your confidential materials will be shredded as you watch. Please bring paper only; plastic bags, metal, binders and binder clips cannot be shredded. (Paper clips and staples are acceptable)

100% of the paper is recycled and is applied to Medford's recycling totals, for which we obtain grants from the State of NJ under the Clean Communities Program and Recycling Tonnage Grant Program.

The DPW Yard/Township Garage is open from 8:00 am till 1:00 pm to accept all other waste and recycling materials.


HUNTING PROHIBITED IN TWP. PARKS & OPEN SPACE AREAS

Per The Township's Administrative Code #109-3 (Parks & Playgrounds), it is prohibited to "hold, posses, or use any firearm or weapon in or within 300 feet of any park, playground or open space area," and "molest, trap, capture or hunt, remove, injure or kill any animal or disturb its habitat, except in portions of any park or open space area designated as open for fishing."

EARLY VOTING & VOTE BY MAIL

In-person early voting for the November 7th General Election will begin on Saturday, October 28th and continue through Sunday, November 5th. Early voting polls will be open from 10:00 a.m. to 8:00 p.m. on weekdays and Saturday and from 10:00 a.m. to 6:00 p.m. on Sunday.

Burlington County voters will be able to cast their ballot in person on a voting machine at Medford Town Hall, located at 49 Union Street There are additional early voting locations available throughout Burlington County. The

COUNCIL TRANSFERS OWNERSHIP OF HAINES/TOMLINSON HOUSE TO THE MEDFORD HISTORICAL SOCIETY

After several months of communication with the leadership of the Medford Historical Society (MHS), the Medford Township Council is most pleased to announce that the Historical Society will acquire the historic Haines/Tomlinson House that is directly in front of the Town Hall & Library Building at 51 Union Street.

This historic house stands on .801 acres of subdivided property. Built in 1760, it is a brick

colonial farmhouse believed to be the oldest house in what is known as Medford Village. The house was originally built by the prominent Haines family but was also used as the residence and law office of former Medford Mayor Ephraim Tomlinson.

The Historical Society hopes that with the help of Medford supporters, businesses, the Township, and volunteers that this property will become an attractive and stable anchor to Medford Village and bring the Historical Society's presence to the heart of Medford.

The Medford Historical Society is primarily organized around Project Leaders for events and properties. Medford village resident Michael Gallagher will lead the effort to restore and maintain the Haines/Tomlinson House. Mike is a Research Ecologist (Ph.D.) with the U.S. Forestry Service. Mike says his real love is history, but somehow finds himself as an ecologist!

Activities at the Haines/Tomlinson house will include a museum showcasing local history. Anyone with artifacts that they would like to donate may direct them to either the Kirby's Mill or Haines/Tomlinson museums by contacting the Medford Historical Society at: contactus@medfordhistory.org or via Medford Historical Society, PO Box 362, Medford NJ 08055.
